NHS England (NHSE) recognises that there are a range of providers of lived experience services, from large organisations through to micro-enterprises. Committed to readying and enabling all provider types to provide these services to NHSE, this PIN serves to:

- 1) Advise the market of the planned forthcoming opportunity to apply for a place on this framework;
- 2) Advise the market of a planned market engagement event, designed to explore, understand, and address the pressures and challenges that lived experience providers face.

It is anticipated that this framework will open to new providers in January 2021. Being on this framework means that providers will be eligible to provide services through call-offs, or mini competition.
