Commercially Supported Shipping, part of the UK Ministry of Defence ("MoD") intends to proceed to award a contract for the provision of Classification Society Services to Lloyd's Register EMEA ("Lloyds") using the negotiated procedure without prior publication of a contract notice pursuant to Article 28(1)(e) of Directive 2009/81/EC (Regulation 16(1)(a)(ii) of the Defence and Security Public Contracts Regulations 2011) for technical reasons.
